SUMMARY

<u>CPIH</u>

The Consumer Prices Index including owner occupiers' housing costs (CPIH) is the most comprehensive measure of inflation. It extends the Consumer Prices Index (CPI) to include a measure of the costs associated with owning, maintaining and living in one's own home, known as owner occupiers' housing costs (OOH), along with council tax. Both of these are significant expenses for many households and are not included in the CPI.

Aside from including owner occupiers' housing costs (OOH) and council tax, CPIH is otherwise identical to CPI. This means that, aside from these two components, the factors contributing to the CPI rate are the same as those contributing to the CPIH. For example, if food is reported as increasing the CPIH rate, it is also acting to increase the CPI rate. The size of the contributions for components other than OOH and council tax are exaggerated in the CPI compared with the CPIH because they account for a larger proportion of the overall index.

The <u>National Statistics</u> status of the Consumer Prices Index including owner occupiers' housing costs (CPIH) was reinstated on 31 July 2017. <u>A letter</u> from the Director General for Regulation to the National Statistician detailed the actions that were taken to meet the requirements as set out in the <u>CPIH assessment report</u>.

The main movements for CPIH in May 2018 are:

- The all items CPIH is 105.9, up from 105.5 in April.
- The all items CPIH annual rate is 2.3%, up from 2.2% in April.
- The annual rate for CPIH excluding indirect taxes, CPIHY, is 2.1%, unchanged from last month.
- The OOH component of CPIH is 105.4, up from 105.3 in April.
- The OOH component annual rate is 1.1%, down from 1.2% last month.
- The CPIH all goods index is 104.2, up from 103.8 in April.
- The CPIH all goods index annual rate is 2.5%, down from 2.6% last month.
- The CPIH all services index is 107.1, up from 106.8 in April.
- The CPIH all services index annual rate is 2.1%, up from 1.9% last month.

Consumer Prices Index (CPI)

The CPI continues to be a National Statistic and is a measure of consumer price inflation produced to international standards and in line with European regulations. First published in 1997 as the



Harmonised Index of Consumer Prices (HICP), the CPI is the inflation measure used in the Government's target for inflation.

The CPI is also used for purposes such as uprating pensions, wages and benefits and can aid in the understanding of inflation on family budgets. For more information see <u>Users and uses of consumer price inflation statistics</u>.

The main movements for CPI in May 2018 are:

- The all items CPI is 105.8, up from 105.4 in April.
- The all items CPI annual rate is 2.4%, unchanged from last month.
- The annual rate for CPI excluding indirect taxes, CPIY, is 2.4%, unchanged from last month.
- The annual rate for CPI at constant tax rates, CPI-CT, is 2.3%, unchanged from last month.
- The CPI all goods index is 104.2, up from 103.8 in April.
- The CPI all goods index annual rate is 2.5%, down from 2.6% last month.
- The CPI all services index is 107.6, up from 107.2 in April.
- The CPI all services index annual rate is 2.3%, up from 2.1% last month.

Retail Prices Index (RPI)

In accordance with the Statistics and Registration Service Act 2007, the Retail Prices Index and its derivatives have been assessed against the Code of Practice for Official Statistics and found not to meet the required standard for designation as National Statistics. The <u>full</u> <u>assessment report</u> can be found on the UK Statistics Authority website.

The RPI is a legacy measure of UK inflation that continues to be published because of its use in long-term contracts and index-linked gilts. For further information see <u>Users and uses of consumer</u> <u>price inflation statistics</u>.

The main movements for RPI in May 2018 are:

- The all items RPI is 280.7, up from 279.7 in April.
- The all items RPI annual rate is 3.3%, down from 3.4% last month.
- The annual rate for RPIX, the all items RPI excluding mortgage interest payments (MIPs), is 3.4%, unchanged from last month.
- The all goods RPI is 213.8, up from 212.8 in April.
- The all goods RPI annual rate is 3.6%, unchanged from last month.
- The all services RPI is 381.6, up from 380.2 in April.
- The all services RPI annual rate is 3.0%, up from 2.9% last month.

A large upward effect came from:

Transport, principally from motor fuels, air fares and sea fares. Petrol prices rose by 4.6 pence per litre between April and May 2018 to stand at 125.3 pence per litre in May, the highest average price since October 2014. This compares with a 1.0 pence per litre fall between the same two months of 2017 to stand at 116.4 pence per litre in May 2017. Similarly, diesel prices rose by 4.7 pence per litre between April and May 2018 compared with a 1.6 pence per litre fall between the same two months of crude oil. There were also large upward effects from air and sea fares. Fares in both categories rose between April and May this year but fell between the same two months a year ago. The timing of Easter in the middle of April 2017

contributed to relatively high fares in that month with subsequent price falls into May 2017. This year, Easter fell at the beginning of April before the price collection period leading to relatively lower fares being observed and subsequent price rises into May.

Large downward effects came from:

- Recreation and culture, where prices, overall, rose by 0.1% between April and May this year compared with a larger rise of 0.9% between the same two months a year ago. The main effect came from games, toys and hobbies, where prices fell this year but rose a year ago, particularly for computer games. Prices for these games are heavily dependent on the composition of bestseller charts, often resulting in large overall price changes from month to month;
- Housing, water, electricity, gas and other fuels, with domestic electricity prices rising by 0.1% between April and May this year compared with 4.0% between the same two months a year ago; and
- Food and non-alcoholic beverages, with the largest single effect coming from sugar, jam, syrups, chocolate and confectionery, where prices fell this year but rose a year ago.
 Partially offsetting this was a small upward effect from vegetables, where prices rose this year but fell a year ago.

Small downward effects came from:

- Furniture, household equipment and maintenance, where prices overall rose by 0.6% between April and May 2018 compared with a larger rise of 1.2% between the same two months a year ago;
- **Restaurants and hotels**, where prices overall rose by 0.4% this year compared with a larger rise of 0.5% a year ago. The contribution came almost entirely from accommodation services; and
- **Clothing and footwear**, where prices overall rose by 0.2% this year compared with a larger rise of 0.5% a year ago.

Bread and cereals

- Small upward effect.
- Prices overall were little changed this year but fell a year ago, with the main upward contributions coming from packs of individual cakes, chocolate biscuits and dried potted snacks.
- Partially offset by small downward contributions coming from chilled pizzas, breakfast cereals and sponge cakes, where prices fell this year but rose a year ago.

Meat

- Small downward effect.
- Prices overall fell this year by more than a year ago, with the main downward contributions coming from beef and pork.

Milk, cheese and eggs

- Small downward effect.
- Prices overall fell this year but rose a year ago, particularly for cheese spread.
- Partially offset by a small upward contribution coming from yoghurt/fromage frais, where prices overall rose this year but fell a year ago.

Oils and fats

- Small downward effect.
- Prices overall fell this year but rose a year ago, particularly for margarine/low fat spread.

Vegetables including potatoes

- Small upward effect.
- Prices overall rose this year but fell a year ago, particularly for premium potato crisps and fresh lettuces.
- Partially offset by a small downward contribution coming from fresh cauliflowers, where prices overall fell this year but rose a year ago.

Sugar, jam, syrups, chocolate and confectionery

- Small downward effect.
- Prices overall fell this year but rose a year ago, with the main downward contributions coming from cartons/boxes of chocolates and ice cream.
- Partially offset by small upward contributions coming from chocolate covered ice cream bars and bags of non-chocolate sweets.





 - **Household consumables**, where prices overall rose this year by more than a year ago, with the main upward contributions coming from household cleaner cream/liquid and kitchen rolls.

RECONCILIATION OF CPI AND RPI

(Table 5 of the Consumer Price Inflation Dataset)

This table identifies the main factors contributing to the differences between the unrounded inflation rates for the CPI and the RPI. These differences are broken down into: mortgage interest payments, other housing components excluded from the CPI, other differences in the coverage of goods and services, and the formula effect. The final column titled 'other differences including weights' is derived as a residual.

This table currently compares CPI with RPI. In due course it will be updated to compare CPIH with RPI.

The difference between the CPI and RPI unrounded annual rates in May 2018 was -0.91 percentage points, narrowing from -0.96 percentage points in April 2018.

The main factors contributing to the narrowing were:

- Other housing components excluded from the CPI, which decreased the RPI 12-month rate relative to the CPI 12-month rate by 0.09 percentage points between April and May 2018. The effect came mainly from house depreciation.
- **The formula effect**, which decreased the RPI 12-month rate relative to the CPI 12-month rate by 0.04 percentage points between April and May 2018. The effect came mainly from clothing and footwear; and recreation and culture.
- Mortgage interest payments, which decreased the RPI 12-month rate by 0.02 percentage points between April and May 2018 but are excluded from the CPI.

The main offsetting factor was:

• Other differences including weights, which increased the RPI 12-month rate relative to the CPI 12-month rate by 0.10 percentage points between April and May 2018. The effect came mainly from air fares; games, toys and hobbies and equipment for sport and open air recreation; and clothing and footwear. This was partially offset by sea fares; insurance; and furniture and furnishings, carpets and household textiles.



OUTLOOK

FOOD

Seasonal Food

• Seasonal food prices have shown a mixed pattern of rises and falls in June of recent years, but are typically dependent on weather conditions both in the UK and around the world.

HOUSING, WATER, ELECTRICITY, GAS AND OTHER FUELS

Electricity, Gas and Other Fuels

- British Gas has announced an increase in their default standard variable tariff (SVT) from 29 May 2018. The price for a typical dual fuel customer on this tariff will go up on average by £60 to £1,161 £30 for gas and £30 for electricity. (britishgas.co.uk 10 April 2018)
- EDF Energy has announced a change to its standard variable electricity tariff, effective from



7 June 2018. EDF Energy's standard variable dual fuel Direct Debit tariff will increase by 1.4% to £1,158 a year following an increase in the standing charge for electricity to 23.28p a day, an increase of 2.7% on a typical electricity bill. There will be no change to gas prices for Direct Debit customers. There will also be an increase in the charges for customers choosing to pay by cash or cheque by £6 per fuel per year, applying to standard variable tariffs and future fixed tariffs. A dual fuel standard variable customer choosing to pay by cash or cheque will see a combined increase of £28 a year (+2.3%) to £1,248 a year. (edfenergy.com 12 April 2018)

- ScottishPower has announced its standard variable domestic gas and electricity prices will increase from 1 June 2018. The majority of customers affected, who pay by Monthly Direct Debit, will see an average increase of 5.5%, or £63 on a typical annual dual fuel bill. (scottishpower.com 20 April 2018)
- Npower has announced a change to its Standard Variable and Juice tariffs. From 17 June the cost of a typical dual fuel energy bill will be going up by 5.3%, or £64 a year on average. Gas prices will go up by an average of 4.4%. Electricity prices will go up by an average of 6.2%. (npower.com 11 May 2018)
- SSE has announced an increase to standard electricity and gas prices in a change that will increase a typical dual fuel bill by an average of 6.7%, effective from 11 July 2018. This rise equates to an increase of 5.7% for gas and 7.7% for electricity, meaning a typical dual fuel customer will see a rise of around £1.50 each week. Customers who are on fixed-price tariffs, have a prepayment meter, or are on the vulnerable customer safeguard tariff will not be affected. SSE Energy Services will also be removing its £6 per fuel per year paperless billing discount from 11 July 2018. (sse.com 30 May 2018)

FURNITURE, HOUSEHOLD EQUIPMENT AND MAINTENANCE

TRANSPORT

Fuels and Lubricants

- Oil prices have fallen slightly, due to rising Russian production and the highest U.S. drilling activity in more than three years, but are supported by concerns over future Iranian and Venezuelan output. Benchmark Brent crude was down 15 cents at \$76.31 a barrel. U.S. light crude was 10 cents lower at \$65.64. (uk.reuters.com 11 June 2018)
- When considering the price of petrol between May and June 2018, it may be useful to note that the average price of petrol fell by 1.1 pence per litre between May and June 2017, to stand at 115.3 pence per litre as measured in the CPIH.
- A 1 pence change on average in the cost of a litre of motor fuel contributes approximately 0.02 percentage points to the 1-month change in the CPIH.

Passenger Transport by Air

• With the exception of 2013, air fares have tended to rise in June.

HOUSING (RPI)

Mortgage interest payments (MIPs)

- The Bank of England Bank Rate remained unchanged at 0.5% on Thursday 10 May 2018. The next announcement and minutes from the Bank of England's Monetary Policy Committee are scheduled to be published on 21 June 2018.
- The change in average mortgage interest rates recorded in the RPI was -0.02 percentage points between May and June 2017. The Bank of England Bank Rate remained unchanged at 0.25% in May 2017.
- A one percentage point change in the average mortgage interest rate contributes approximately 1.0 percentage points to the 1-month percentage change in the RPI.
